

AAO RESIDENT OF THE YEAR AWARD

The Resident of the Year award is conferred by the Academy to recognize the resident who has contributed to the Academy, has contributed to osteopathic principles and practices at their residency program, and who has participated in Academy events, including, but not limited to, AAO Convocation, AOA OMED conference, and/or AAO educational programs.

Nominated individuals exhibit osteopathic principles and practices at their residency programs and encourage other residents, faculty and students to continue to use osteopathic principles and practice during their residency career and practice. An application with a brief description/essay of why this individual is deserving of this award is submitted to the AAO Awards Committee.

An AAO component society or ACGME approved osteopathic residency program may submit only one (1) nomination per organization or residency program. All residency programs are encouraged to nominate their top candidate each year. Previous nominations have been received from the following programs. Personal Statement

The nominee shall provide a personal statement of not more than one page. It should illustrate why the nominee feels he/she is qualified to receive this award. It should demonstrate how the nominee meets the eligibility criteria: commitment to osteopathic philosophy and the profession; leadership skills and demonstrated use of these skills; noteworthy accomplishments demonstrating his/her role as a leader; demonstrated contributions in osteopathic organizations, such as teaching, committee work, and national associations; and his/her outstanding character and drive to be a leader. It should also highlight activities and/or experiences that may add to the individual's worthiness to receive this award. The AAO Awards Committee would like to know what the nominee's future goals may be in respect to leadership within the osteopathic profession and what steps have been taken toward exploring and realizing those goals.

Letters of Recommendation from the Nominator

The letters of recommendation should demonstrate why the nominee should receive this award.

• The letter from the Nominator shall state why this nominee was chosen for this award and demonstrate how the individual meets the eligibility criteria.
